- Apply: One coat ROCEpoxy High Solids Epoxy Primer HS9300 and Two coats of ROCEpoxy Directto-Metal Epoxy Mastic 9100 per their Technical Data Sheet recommendations

Immersion:

- Surface Preparation: SSPC-SP10 Near White Metal Blast
- Apply: Three coats of ROCEpoxy Direct-to-Metal Epoxy Mastic 9100 per the Technical Data Sheet recommendations

FIVE-YEAR RUST- PROOF GUARANTEE LIMITED PRORATED MATERIAL ONLY GUARANTEE

Rust-Oleum Corporation guarantees, for a period of up to 60 months from the date of application, that its products are free from defects in materials and workmanship and will protect the surface from rusting when applied and maintained in strict compliance with proper surface preparation and application (primer/finish coats) as recommended in this document.

THIS GUARANTEE DOES NOT COVER:

Dissatisfaction, problems, defects or damage due to application or maintenance other than as recommended by Rust-Oleum in its printed labels, literature, Technical Data Sheets, and specifications; slight color changes, fading, or reduction in gloss; damage due to accidents or damage caused by chemicals not approved for exposure by Rust-Oleum. Areas of rusting which have resulted from unintended or intended damage during shipment or construction, or from physical or mechanical abuse, or from Owner's failure to perform the normal maintenance referred to above, including but not limited to damage from welding, interior heating, or war, fire, explosion, catastrophe, or any event or service beyond normal intended usage, as disclosed to RUST-OLEUM, shall be excluded and shall be considered normal maintenance items, correction of which shall be the sole responsibility of Owner. Any re-coating or alteration of any surface covered by this guarantee by any person or entity prior to Rust-Oleum's inspection and approval shall invalidate this guarantee. In all instances Rust-Oleum shall be the sole judge as to whether a partial or complete re-coating of the rusted area(s) is required to fulfill its obligation under this guarantee, and Rust-Oleum reserves the right to select the products to be used to remedy the situation. Further, this guarantee is not transferable and may not be modified or enlarged in scope by any representative, agent or employee of Rust-Oleum. Guarantee only applies to products designated with the Rust-Proof Guarantee logo. NOTICE OF CLAIMS

All claims must be made in writing and sent to Rust-Oleum Technical Services Department, 11 Hawthorn Pkwy, Vernon Hills, IL 60061 or emailed to technicalservice@rustoleum.com. Status of claims will be based on complete inspection of application. All claims must be made within thirty days of owner learning the facts upon which such claim is based. All claims not submitted in writing and received by Rust-Oleum within the time period specified above shall be waived. Proof of purchase must be provided. Rust-Oleum's laboratory will analyze and report reasons for the alleged product failure within 30 days of receiving the claim. If necessary, a field Inspection will be conducted within these 30 days. Owner may pay for an independent, recognized coating failure laboratory to determine cause of alleged failure. A third-party laboratory will be hired to determine reasons for alleged failure if the conclusions reached by the laboratories described above are inconsistent. The costs of such third-party laboratory testing will be shared on an equal basis by Rust-Oleum and Owner.

LIMITATIONS OF LIABILITY

The purchaser's and owner's sole and exclusive remedy against Rust-Oleum for claims arising thereunder for any and all losses and damages resulting from any cause shall be the receipt of an equivalent amount of material to replace the defective material or, at the discretion of Rust-Oleum, the refund of the purchase price for such defective material. In no event, shall Rust-Oleum be liable for direct, incidental, or consequential damages.
